

Collecting and processing personal data

Why does Akkerman Exploration B.V. need to collect this data?

How long do we keep your personal data for?

The data you have submitted will be stored for a maximum of one year.

Who will it be shared with?

We will not disclose your personal data to third-parties unless this is required by law, or if it is necessary to fulfil or process agreements with you.

Messaging visitors to the website

The website of **Akkerman Exploration B.V.** collects visitor data, including your IP-address, moment of visiting and data transferred by your browser. Google Analytics

The data collected by Google Analytics will be transferred to a Google server in the United States, including you IP-address.
